WRITTEN REPORT ON THE USE OF THE GOVERNMENT FUNDING OF 2020

According to Act L of 2018 on the Central Budget of Hungary 2019, Section XI. Prime Minister's Office, Chapter 30 Managed Appropriations, Subchapter 1 Appropriations managed by the Prime Minister's Office, Paragraph 92 a contribution as an appropriation of HUF 400.0 million for the operation and performance of the Otto von Habsburg Foundation has been allocated by the Prime Minister's Office, which act has concluded in a grant agreement with the above stated Foundation.

Besides funds based on Government Decision 1099/2017 (III.6.) on the establishment of the Otto von Habsburg Foundation and the provision of the necessary conditions and resources for its operation and based on Government Decision 1313/2017 (VI.6.8.) on the transfer of appropriations from the National Defence Fund and on the amendment of certain government decisions, the Foundation did not generate any income in 2020.

In order to support the performance of the 2020 operational and professional tasks related to the public tasks of the Otto Habsburg Foundation, on 23 March 2020, it concluded a Grant Agreement with the Prime Minister on the registration number GF/JSZF/151/8/2020. In view of the epidemiological situation, the Sponsor authorized the extension of the duration of the supported activity specified in point 3 of the Grant Agreement by no more than 3 months in the letter NEÜHÁT / 438/2 (2020) after the Foundation submitted an application for the use of budget support. Considering that in accordance with Article 50 of the Grant Agreement and Section 95 (6) (a) of Government Decree 368/2011 (XII. 31.) on the implementation of the duate of the related use and reporting deadline did not exceed the three-month delay compared to the deadline set in the Grant Agreement, the Grant Agreement was not amended. Duration of the supported activity: 1 January 2020 - 31 January 2021. The deadline for use is the 28th day following the duration of the supported activity. The deadline for submission of the report is 31 days after the deadline for use.

The use of the HUF 400.0 million non-refundable budget support provided under the above stated Grant Agreement in 2020 was as follows.

FINANCIAL REPORT

The remuneration of the seven members of the Board of the Curatorial Board, the three members of the Supervisory Board and the three members of the Access Committee assisting archival research is set out in KTHÁT / 446/17/2017. established on the basis of the Foundation's founding document. From Based on the Founding Resolutions 4/2018 (XII.20.) And 3/2018. (XII.20.) from 1 January 2019, for a definite period of three years the number of members of the Supervisory Board was increased by two further members.

Their remuneration is the same as in the founding resolution on the remuneration of the members of the Supervisory Board. Annexes 1 and 2 to the heritage assessed and inventoried under the lease agreement concluded between the OVH Archiv Stiftung and the Foundation on the basis of the decision of the Board (Decision No. 15/2019 (VI.3.) On 3 June 2019 have been approved. This date also marked the beginning of the operation of the Access Committee.

The director, appointed by the Founder to ensure the operational management of the Foundation and the continuous implementation of the Foundation's goals, performed the tasks of 2020 with 13 employees for a significant part of the year. The staff of the office was slightly reorganized, two employees were hired for the collection area within the permitted number of staff, and the employment of two people was terminated by mutual agreement at the end of the year.

PERSONNEL EXPENSES (PERSONAL ALLOWANCES AND EMPLOYER'S STATE CONTRIBUTIONS)

In its financial plan for 2020 the Foundation planned an appropriation of HUF 195.6 million for personal allowances. These expenses were planned to cover the allowances of the members of the Curatorial Board, the Supervisory Board and the Access Committee, the salaries and other allowances of the employees of the Foundation (cafeteria, travel passes, commuting expenses), payment of contract staff, the fee of the scientific call for papers jury and the prize of the winners of the competition, daily subsistence allowance for missions abroad and representation expenses.

By the end of the year, the remuneration for the senior executives of the Foundation was HUF 45.4 million, for the Supervisory Board HUF 26.4 million, for the Access Committee HUF 3.6 million, for the employees of the Foundation HUF 99.2 million, for contracted individuals HUF 14,4 million was paid and for state contributions HUF 24.1 million were used.

For the first and second prize of the call for papers "My country is a Christian Europe" HUF 0.5 million was paid.

We spent HUF 3.5 million on representational costs.

MATERIAL EXPENSES

Actual expenses regarding professional and operational materials include the purchase of office supplies and equipment, newspaper subscriptions, professional materials, and car-maintenance costs amounting to HUF 3.1 million.

Service expenses include telephone and internet costs, postal service fees, rents (heritage, office, garage, car maintenance fee), operating costs, legal, accounting, auditing fees, the payment of graphic design, archiving, online, simultaneous interpretation and proofreading services and bank charges as follows:

Based on the lease agreement concluded between the Foundation and the OVH Archiv Stiftung on 19 December 2018, a rent of EUR 100,000 was paid in 2020. The paid amount is HUF 33.7 million at the central rate published by the Hungarian National Bank and the VAT payment obligation meant an additional expenditure of HUF 9.1 million. The exchange rate difference is HUF 1.6 million.

The Foundation paid HUF 16.3 million in rent and operating fees to the Hungarian Lutheran Church. The garage rent was HUF 0.5 million for the whole year.

HUF 7.7 million was paid for the Foundation's accounting and auditing services and HUF 32.1 million for legal advice and representation. In June, the term of office of the three members of the Board of Trustees and the Supervisory Board expired, and the new appointment and acceptance for another three years were confirmed. The costs of this and the costs related to board meetings held during the year are included in attorney expenses.

The bank fee of the Foundation's bank account is HUF 1.9 million.

Among the event-related expenses representation and allowances for individuals employed on a contract basis are included in the personal allowances.

Material expenses include the costs of proofreading, moderation, journalism, photography, translation and interpretation, communication, roll-up planning, production, advertising, online services, and printing costs.

Accumulation expenses include the purchase of studies, a projector and a microphone.

We paid a total of HUF 8.4 million for event organization and other event-related services.

A total of HUF 1.1 million was paid on foreign and domestic missions.

The amount of advertising and propaganda expenses (advertising material, conference materials, business card production) was HUF 3.3 million.

Depreciation in 2020 was HUF 6.9 million.

OTHER EXPENSES

HUF 0.6 million was paid under company car tax, and HUF 0.1 million was paid for other expenses.

EXPENDITURE ON FINANCIAL OPERATIONS

The transaction interest paid for the unused subsidy in 2019 is HUF 0.4 million, the exchange rate difference generated during the lease of the heritage to OVH Archiv Stiftung and other payments in foreign currency is HUF 1.6 million.

ACCUMULATION EXPENSES

According to the contract concluded with the Motion Picture Public Foundation of Hungary, the MPPFH granted the Foundation the right to use interviews, pictures and documentaries made with or about Otto von Habsburg. The amount paid for this is HUF 4.9 million.

In connection with the conference titled *Legitimists Between the Two World Wars*, held on October 15, 2020, we asked 8 people to write studies, the total cost of which was HUF 1.1 million.

We further expanded the Foundation's collection related to Otto von Habsburg: small sculptures, medals, a bust, photos, correspondence material, newspapers, VHS cassettes were purchased in the amount of HUF 1.3 million.

We spent HUF 5.1 million on the introduction of the Qulto digital archive and collection management system.

Government Decision 301/2018 (XII.27.) on the centralized public procurement system of IT procurements of the Digital Government Agency extends to the Foundation. Given that expenditures did not reach the public procurement threshold in 2020, no public procurement procedure was conducted.

Until 31 December 2020, the Foundation accounted for HUF 7.4 million of its own assets of HUF 100.0 million, which includes expenses not eligible for the grant (transaction interest, accruals, taxes and surcharges due to self-revision, and due to a decision of the Board of Trustees a payment of arrears).

PROFESSIONAL REPORT

Following the establishment of the Otto von Habsburg Foundation in 2017, and the arrival of the heritage in the autumn of 2018, we developed the necessary infrastructure and hired colleagues in 2019.

We have compiled our plans for 2020 in accordance with the experience gained in 2019, continuing the work focusing on the life and historical heritage of Otto von Habsburg. At the same time, we are constantly broadening our perspective towards how the intellectual legacy can be adapted to today's situations. In the focus of our activities is still the continued processing and sharing of the collection. However, thorough planning and preparations were dragged through by increasingly stringent epidemiological regulations in the spring of 2020, due to which, while maintaining the main objectives, complete redesign was required.

Instead of personal meetings, conferences had to be conducted online, which proved to be an increasingly successful way of working after the initial difficulties. Accordingly, there have been huge savings that we would like to use for the 2021 programs. The decrease in the number of public events resulted in the ability to pay more attention to the processing the collection. Collection processing methods also had to be adapted to the pandemic situation.

COLLECTION

As of January 1, 2020, historian Gergely Fejérdy Ph.D. took over the responsibilities of Tamás Sávoly as Deputy Scientific Director. Following the review of the previously performed tasks, the below steps have been taken over the past year.

Defining the Organizing Principles of the Collection

Between January and March 2020, based on the work started in 2019 and the work plans submitted at the beginning of 2020 with the help of Professor Lajos Gecsényi, former director of the State Archives of the National Archives of Hungary, we determined the principles of processing and listing. We have developed and adopted a structure to help process the resources in the collection, which would be finalized by the end of January, 2021.

Selection of the Collection Management Software

During 2019 the selection of the collection management software was not finished, thus in 2020 the Foundation made the decision to proceed with the subscription to the widely accepted Monguz/Qulto system, as it has been already successfully used in many Hungarian and Central European public collections. The software is suitable for the combined management of books, images, sound recordings, films and archives, and for the fast, professional service of future researchers.

Based on an agreement with Qulto in October 2020, the software settings are defined to take into account the specific needs of the Foundation. In November 2020 the collection's already completed lists were uploaded and the colleagues working on the collection received a training on how to use the system. The test period has begun, during which we are having the opportunity to indicate our questions and modification needs that occur through the processing of the collection material.

Digitalization

In 2019 audio-visual material was digitalized in the first place. Regarding the archives the decision on digitalization - after the consideration of several options - was made in September 2020. Taking into account quality, cost efficiency and speed, a preliminary agreement was made with Arcanum Database Ltd. The first trial-digitalization took place in November 2020. Audio-visual material can be digitized by the Foundation in its own authority with the Epson Perfection V800 photo scanner acquired in 2019. The scanner can process unique photographic material with this method, which is of great help to the Foundation's online appearance.

Processed Archival Collection Units

From March 12, 2020, the work performed was inspected and tasks ahead were identified on a monthly basis. These have been summarized and filed. In the past year, the following collection units have been processed partially or entirely:

- Sorting, palliumizing, stamping and listing of the *Hungarian correspondence* (HOAL I-2-c) between 1986 and 2011 is finished until the end of January, 2021. This means a detailed processing of a total of approx. 20,000 pages of mailing. Previously sorted Hungarian correspondence has been, therefore, entirely processed. Until the end of January 2021, the entire correspondence is being ABC-sorted. The revision and, in some cases, the standardization of the lists, which also take into account the requirements of the Qulto system, are still in progress, but as a result of the work already done it is possible to share Otto von Habsburg's Hungarian correspondence between 1986 and 2011 and a list of the Hungarian persons with whom the former Crown Prince corresponded on our website in the first half of 2021.
- Sorting, listing and digitalization of the *diplomas and awards* (HOAL I-6-a) a total of 137 units have been completed.

- The sorting and listing of the photo material (HOAL I-5), which has begun in 2019, was continued in 2020 as well. As of January 1, 2020, based on the current status, six document containers, a total of 7,200 photos were listed and sorted, 2/3 of the material was digitalized.
- A detailed plan has been drawn up for the archival material consisting of 46 file containers (HOAL I-1), which was extremely untidy and was kept so far under the heading of private family mailing.
- A listing of the *audio-visual collection* (HOAL I-5-f and HOAL I-5-g) has been completed. Film documents 51 items; and audio documents 186 items, have been relocated. From the film documents, a detailed listing of the family-type "super 8" films 6 pieces was made with the help of Georg von Habsburg.
- Re-boxing and listing of *manuscripts, lectures, speeches and interviews* (HOAL I-4) 19 archiving containers have been completed, a set-up of an arrangement plan begun.

Book collection

Shelving, rationalized structuring and document-type based setting of the book collection sorted in 2019 has been completed in 2020. The separately treated book collection of Queen Zita -18 boxes –was reviewed and thematically selected. Duplicates, triplicates, etc. were registered separately, for a total of about 600 such volumes.

The thematic organization of the book collection has started. We are constantly working on the condition assessment of periodicals, article collections and manuscripts, and on their identification in electronic catalogues. The separate collection and inventory of the volumes written by and about Otto von Habsburg are also in progress. The processing of the library material in the Monguz-Qulto library management software began.

Creation of External Research Opportunities and Databases Related to the Processing of Materials

From mid-March to mid-June 2020, in line with preventing the spread of the Covid-19 virus, the staff of the Foundation's collection department continued the work alternately. This, unfortunately, partly delayed the pace of the planned work, but at the same time provided an opportunity to collect and organize the documents, news, and articles preserved in other public collections that are essential for the processing of the collection material.

Thus, during the home office period, the following resources were collected:

- from the Arcanum database all of the Hungarian articles related to or written by Otto von Habsburg from the period between 1920 and 1989 (the exact data of 700 such documents were entered into a common database available on the Foundation's server);
- a list of textbooks mentioning Otto von Habsburg from the Szaktárs Database;

The collection staff carried out research in Eger, Szombathely, Esztergom and Vác, mainly to review the so-called "Habsburg Masses", the history of ceremonies and banquets held in Hungary on Otto's birthday.

In 2020, the Foundation further expanded its database by purchasing digitalized copies of audio-visual materials (interviews, events) made with Otto von Habsburg, preserved by the Hungarian Motion Picture Treasure Foundation (MMMA). A 15-hour copy and transcript of the 1998 filming of "Napló helyett" became available on the Foundation's server.

We also obtained a digital copy of the documents related to Otto von Habsburg in the legacy of Emil Csonka at the Petőfi Literary Museum. Similarly, we mapped and purchased in digital copy the documents, pictures and letters kept by the Archives of the Archabbey of Pannonhalma concerning the former Crown Prince.

Otto von Habsburg, Life and Heritage. Exhibition Opening at the Royal Palace of Gödöllő

The Otto von Habsburg Foundation launched a traveling exhibition entitled Life and Heritage. The exhibition opening took place at the Royal Palace of Gödöllő on 24 January 2020. The exhibition consists of photographs that were mainly unknown to the greater public until today. The purpose of the traveling exhibition is to present the life and heritage of the European statesman in those Hungarian settlements who awarded Otto von Habsburg the title of honorary citizen. At the opening ceremony György Gémesi, Mayor of Gödöllő, Dr. Tamás Ujváry, Director of the Royal Palace of Gödöllő said welcoming words, and János Martonyi, former Foreign Minister of Hungary, gave a speech. István Nagy, Chair of the Board of the Foundation recommended the exhibition to those who were interested. Number of people present: 176. Instead of an International Conference - on the 70th Anniversary of the Schuman Plan

Date: 11 May 2020

On the occasion of this round anniversary, the Otto von Habsburg Foundation and the Institute of Strategic Studies of the National University of Public Service had intended to examine, in the framework of an international conference due to begin on May 11, whether the Plan formulated at the beginning of the European integration process and the heritage of the mainly Christian Democrat politicians supporting the Plan, still bear a message relevant to this day. Although the event had to be cancelled due to the pandemic, most of the invited speakers undertook to briefly summarize their thoughts on the subject in writing-thus paying tribute to Robert Schuman's initiative. Legitimists between the two world wars - online conference

Date: June-July 2020

Otto von Habsburg's oeuvre, his thinking about Hungary and Europe, and its changes during his life can only be understood if we systematically examine the earlier periods of his career and his role in public life, as well as the development of public opinion about him. The meeting was originally scheduled to take place live in the late spring of this year.

However, in view of the coronavirus situation, we decided to publish the lectures in electronic form on an ongoing basis.

Our aim was to highlight that after the Trianon decision, the legitimists had very different causes and manifestations, and to point out how the young Crown Prince living in emigration was present in Hungarian and Central European public discourse in many ways, from the fairy-tale prince's children's literary figure to real political involvement.

We involved Hungarian historians dealing with the topic: Dávid Ligeti, László Anka, Vince Paál, Tamás Tarján, András Zima, Anikó Glässerné Nagyillés, Róbert Fiziker and Máté Botos. Director Gergely Prohle and Georg von Habsburg Member of the Board of the Foundation introduced the work of the Foundation on 15 September in Vienna. The event – with the contribution of the Collegium Hungaricum Wien – was held in the building of the Embassy of Hungary in Vienna. After the welcoming words of the Hungarian Ambassador to Vienna Andor Nagy, Gergely Gulyás Minister of the Prime Minister's Office greeted those who were present. Following the Minister's speech, Director Gergely Prőhle presented the Foundation's activities including the entire processing, the digitalization and filing procedure.

In the second half of the event, a roundtable discussion was held with the participation of Georg von Habsburg, Gergely Prőhle and Emil Brix, the Director of the Diplomatic Academy of Vienna. The discussion was moderated by Iván Bertényi Jr. Deputy Director of the Collegium Hungaricum Wien. In addition to many well-known personalities of Austrian public life, public collection leaders and several members of the Habsburg family also attended the event. Nicole Henter's flute and Srebra Gelleva's piano playing was a worthy musical addition to the occasion.

Rescue and Escape, From 80 years perspective – online conference

Co-organized with the Holocaust Memorial Center. The conference was based on the fact that 80 years ago, in the summer of 1940, through the intervention of Otto Habsburg, thousands of Jewish citizens, mostly of Austrian descent, were able to escape the deportation that awaited them. European and national sovereignty

Date: 9 December, 2020

On the 9th of December 2020, at the initiative of Jean-Pierre Raffarin, former French Prime Minister (2002-2005), the issue of European and national sovereignty was discussed in a French-language online conference, organized by the Otto von Habsburg Foundation and the French Fondation Prospective et Innovation with the participation of the French Embassy of Budapest.

Among the Hungarian speakers were former Foreign Minister János Martonyi, former Minister of Justice and former Member of the European Parliament László Trócsányi and historian journalist Bálint Ablonczy.

From the French point of view besides former French Prime Minister Jean-Pierre Raffarin former ambassadors Pierre Coste and Serge Degallaix took part in the discussion.

Overall, in terms of online views, compared to 2019, we can show higher traffic numbers in all respects. (The website was launched in October 2019, so it is worth looking at it in proportion.) The number of visitors to the articles on the website follows the call for the "Contact" menu item or the "My Country, Christian Europe" competition. In the case of website articles, it can be said that those that have been presented with cross-references on other online interfaces have outstanding traffic indicators. In addition to the event reports, the news and studies related to each anniversary show particularly good numbers. Access to more than 3,000 people is not uncommon for any of our posts on social media. Short video-based content is becoming more and more popular, as it can be seen on our Facebook page as well. In May, we launched a planned paid promotional campaign on Facebook, reaching nearly a thousand followers. We have almost 600 subscribers in our regular newsletter.

The statistical data show that despite the epidemiological restrictions, we managed to maintain and even increase the access to and attendance of events in the online space. The Otto von Habsburg Foundation is becoming more and more known and popular with both the actors of scientific and political public life and the general public.
